The following charges will be payable by the Vendor and will be deducted from the proceeds of each Lot, where sold:

- Commission at the rate of 8% plus GST of the sale price up to \$150,000 and 6.5% plus GST thereafter for the remaining balance on each lot, whether sold by auction, private contract, bought in or otherwise.
- This is a reserved sale. Any lot not sold shall be subject to pass in commission at the rate of 2.5% plus GST of the reserve price.
- A fee of \$200 plus GST will be deducted from the proceeds of each lot sold and put towards prizemoney for the Inglis Race Series.
- A promotional fee of 0.8% will be deducted from all yearlings sold. Of this amount 0.35% will be passed on to assist with funding of Thoroughbred Breeders Australia and 0.45% will be used to fund an Inward Buyers program to this sale.
